Chairman Thorpe called the meeting to order at 4:07 p.m.

**3. Citizen Comments on Non-Agenda Items**

Savannah Dixon, on behalf of the Durant Area Chamber of Commerce - Ms. Dixon presented an overview of the Durant Area Chamber of Commerce Durant Tourism Economic Development Tax Management Fee Proposal. Board Secretary and City Clerk Cynthia Price stated the deadline had passed for the Request for Proposal for Management Team for Durant Tourism Economic Development Authority. Therefore, the proposal would not be accepted. Ms. Price further stated a second publication of the Request for Proposal for Management Team for Durant Tourism Economic Development Authority would run from January 12, 2019 through January 28, 2019.

**4. Administration**

a. Discuss Amendments to Grant Applications and Take Possible Action

No Action Taken

Chairman Thorpe asked Treasurer Greg Buckley to re-address what could happen if grant funds were paid in the beginning, the middle or the end. Mr. Buckley reviewed the possible risks or liabilities that would be assumed by paying all grant funds in the beginning. Mr. Buckley stated it is not illegal to pay all of the grant funds in the beginning but the matter of fiscal responsibility should be considered. Chairman Thorpe stated his position that grant funds should be paid at the end. Trustee Davison stated some entities may not have the resources to wait until after the event. Trustee Hawthorne discussed paying the grant funds in increments. Trustee Calhoun stated his position that any approved grant should have some type of guarantee on it by the principal. Trustee Mendez stated his position that the grant funding should be handled on a case by case basis. Trustee Reed stated the grant process has already been approved by the Authority Board.

b. Discuss Tourism Website and Take Possible Action

No Action Taken

Trustee Reed stated she is now working with Computer Services on the content. Trustee Reed repeated the website must be operational before the billboards go up. Trustee Calhoun inquired if a service agreement with Computer Services had been reduced to writing. Trustee Reed did not know. Trustee Calhoun stated he had not received anything.

c. Discuss Highway Signs and Take Possible Action

Trustee Reed stated the first event sign is ready for placement and should be installed within the next two weeks. Trustee Reed stated the sign would contain contact information for advertising an event. Trustee Mendez suggested allowing local organizations to advertise their events as a courtesy just to get the sign started.

4(d) 2 - This metal art is 7 foot tall. There was discussion as to how it would be stored when not in use. The Durant Area Chamber of Commerce does not have available storage space. Trustee Reed stated she sees it as a prop for photos that could be used at any tourism event within the city. She suggested making it available for use by any of the grants that are approved. Trustee Davison asked Trustee Reed to provide samples of the artists' work at the next meeting.

4(d)3 - Trustee Reed stated the peanut stress balls are a huge hit at the trade shows. Trustee Reed would like to reorder 2000 units.

4(d)4 - Trustee Reed would like to reorder 500 bags.

4(d)5 - Trustee Reed stated the guides would be placed in the hotel rooms. The guests would be encouraged to take the guides with them. Trustee Reed

will provide some examples of guides at a future meeting. No action.
